IN ADDITION, BATH COMMUNITY HOSPITAL HOLDS VARIOUS EVENTS, FREE OF CHARGE, THROUGHOUT THE YEAR THAT BENEFIT THE HEALTH AND WELLNESS OF THE COMMUNITY. IN 2016, THE HOSPITAL HELD 232 DIFFERENT COMMUNITY EVENTS AND SERVED APPROXIMATELY 2,300 PEOPLE. THE HOSPITAL ALSO PROVIDES FINANCIAL ASSISTANCE TO LOW INCOME INDIVIDUALS AND FAMILIES.
